### **1. STOP THE GREAT WALL OF FRANKSTON CAMPAIGN- Progress Report**

1.1 The Campaign has created a Change.org online petition and a QR code link -please support this.



**1.2**, **14 storey** "**Harbour Frankston**" **at 446-450 Nepean Highway** -Council has approved plans for a residential tower despite strong community opposition in the chamber and four councillors strongly opposing. A VCAT appeal has been lodged.

1.2 16 storey 438-444 Nepean Highway-submissions closed 8h December

**1.3 Draft Frankston Major Activity Centre Structure Plan (FMAC)-** submissions closed on 12<sup>th</sup> December.

**1.4 Long Island Residents Association (LIRG) AGM - Prof. Michael Buxton** spoke on plans for high rise development in the Frankston Waterfront. Concern was expressed at the cumulative effect of creating a wall of high rise separating the town centre from the waterfront and detrimental impact of shading and wind on enjoyment of public amenity. Professor Buxton supported the Stop the Great Wall of Frankston Campaign by Long Island Residents, Frankston Beach Association and KCA.

## 2.MELBOURNE WATER DISCHARGE FROM TAYLORS DRAIN INTO THE EEL RACE DRAIN AND KANANOOK CREEK

KCA was notified by Melbourne Water officers of the discharge of treated water through Taylors Drain into the Kananook Creek and into the Bay via the Riviera outfall -this was needed to prevent recent flooding issues in Seaford and Carrum. Water has been pumped/discharged from the Eastern Treatment Plant, with feedback from 14,000 Facebook comments on this. Other comments have been on recent flooding along the Kananook Creek with the recent heavy rain. Watch the EPA Reports for current warnings.
